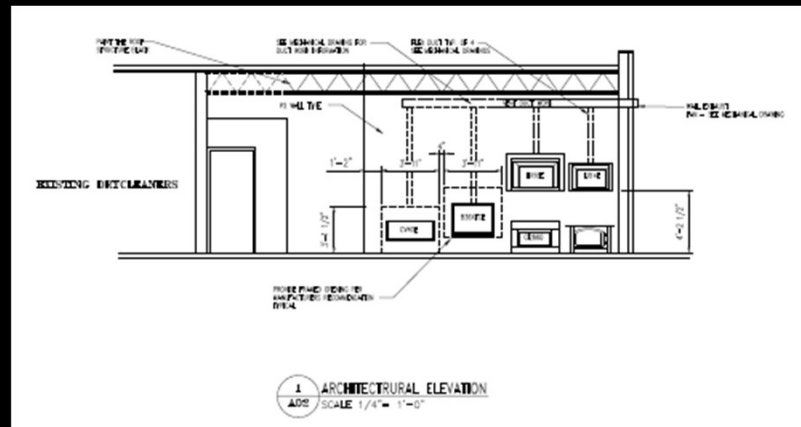
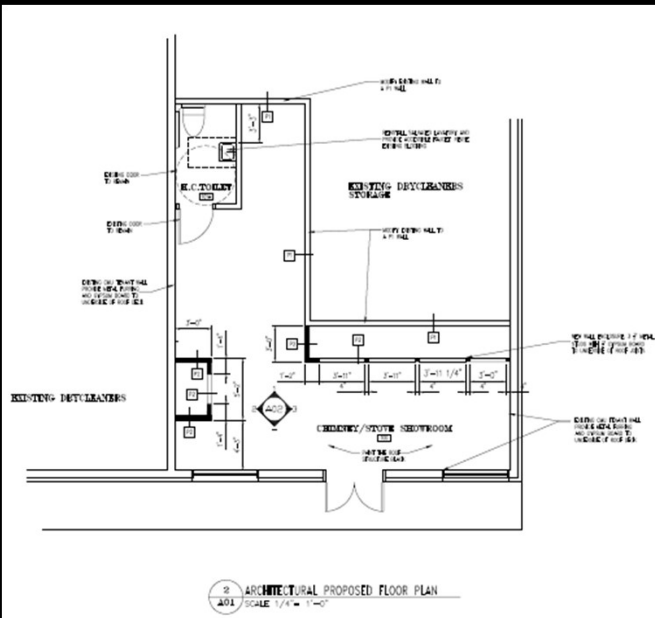

Alans projects have spanned many states including New York, Pennsylvania, California, Maryland, Virginia, and New Jersey.

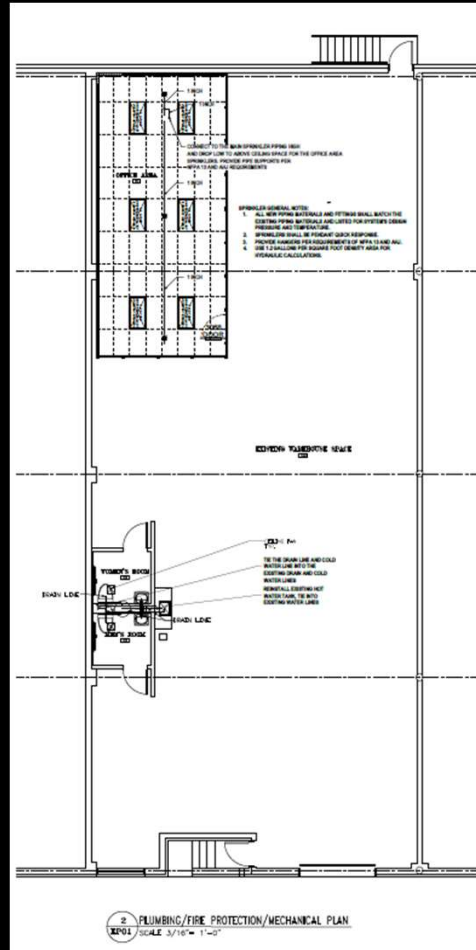
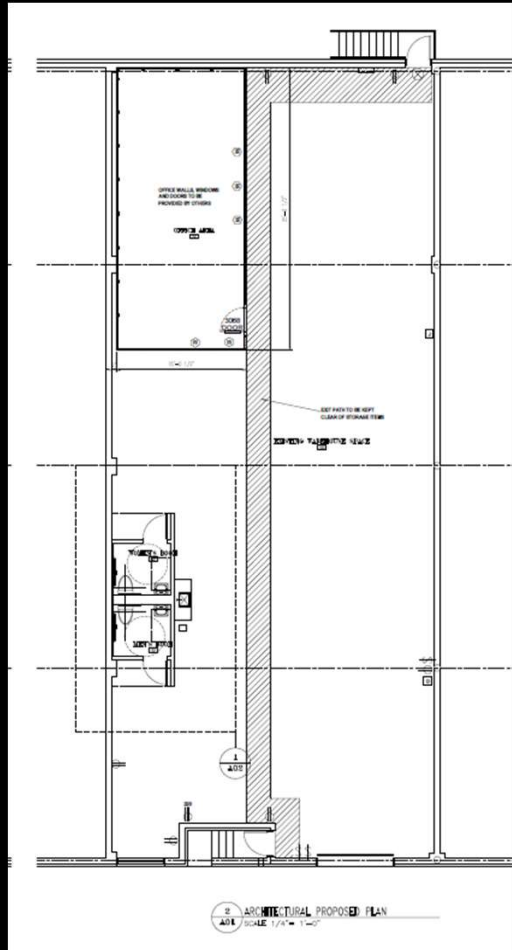
